

- **Build ownership and capacity** of OPDs, especially in the Global South countries to enable them to engage in all relevant processes with local governments and other stakeholders, as equal partners
- Provide global, regional, and national stakeholders a platform to **mobilise** innovative, impactful, and far-reaching **commitments** on disability inclusive development and humanitarian action based on a multi-stakeholder, cross-cutting approach
- **Showcase good practices and evidence** from across the world to inspire change on disability inclusive development and humanitarian action

GDS18:

**171** nationale regeringer, multilaterale organisationer, donorer, fonde, virksomheder og civil samfundsorganisationer afgav **968** forpligtelser.

GDS22:

**1420** nye forpligtelser afgivet af over **190** interesserter, heraf 44 regeringer.

# FORPLIGTELSE – DANMARKS V. GDS22



DANSKE HANDICAPORGANISATIONER

- Denmark will join the **Global Action on Disability (GLAD)** to support multi-stakeholder coordination and to strengthen the knowledgebase across the Danish MFA and in Danish development cooperation.
- Denmark will work to combat gender-based violence in crises. As the global lead of Call to Action on Protection Against Gender-Based Violence in Emergencies **2021-2022**, Denmark is committed to **advocating for the inclusion of people with disabilities in efforts against gender-based violence in humanitarian contexts**.
- Denmark will **support coalition building between OPDs and mainstream organisations** to promote leadership of persons with disabilities by facilitating a strategic dialogue between Disabled People's Organisations Denmark (DPOD) and CSOs that have a strategic partnership agreement with the MFA.
- Denmark will work to **provide a voice for people with disabilities** as outlined in the strategy for development cooperation, the World We Share. Denmark will place a special focus on **strengthening local leadership**, including transfer of funds, ownership and decision-making power to local partners through the close partnership with the Disabled People's Organisations Denmark (DPOD) and through the strategic partnerships with 18 Danish CSOs. The strategic partnerships from 2022-2025 have a strong, increased focus on strengthening local leadership, with a special emphasis on participation for youth, girls and women, and groups in marginalised and vulnerable contexts.<sup>6</sup>

# FORPLIGTELSE – EKSEMPLER FRA GDS22

 Ghanas regering indmeldte 17 forpligtelser, bl.a.:

- Promote inclusion of persons with disabilities in vocational training and higher education,
- Support the building of a diverse disability rights movement and OPDs, including underrepresented groups,
- Develop open, inclusive, and accessible work environments,
- Increase funding to support OPDs' priorities.

 Kenyas regering indmeldte 10 forpligtelser, bl.a.:

- To ensure the needs of persons with disabilities are incorporated in the disaster support strategy,
- To expand social protection programs for Persons with Disabilities and design schemes for their caregivers,
- To provide appropriate health and rehabilitative services to persons with disabilities,
- To promote programs and strategies that address discrimination against women and girls with disabilities.

 Rwandas regering indmeldte 12 forpligtelser, bl.a.:

- By 2024, we will collect data disaggregated by disability, gender, age to inform planning and advocacy by different stakeholders, including Organisations of Persons with Disabilities,
- By 2025, we will support to families of persons with high support needs affected by family conflicts, and climate change,
- By 2023, we will strengthen national disaster response protocols and procedures to ensure that people with disabilities are prioritized and receive appropriate support.

# HVAD VED VI MERE OM GDS25?

- Der forventes også at blive vedtaget en GDS25 deklaration under topmødet
- Der bliver udarbejdet en Global Disability Inclusion Report
- Der er sendt invitationer til regeringer verden over
- Den tyske regering (BMZ) har bevilget 29 mio. EUR til topmødet og forberedelsen
- Fokus på forpligtelser fra regeringer, gerne i samarbejde med civilsamfund eller andre - skal være nye, konkrete og ambitiøse tiltag, der er finansierede!

# HVAD VED VI MERE OM FORPLIGTELSER VED GDS25?



## Kriterier for forpligtelser:

- CRPD-ALIGNED: Handicapkonventionen og andre FN konventioner skal være centrale, og forpligtelserne skal være fuldt i tråd med standarder og ambitioner heri.
- OPD-INCLUSIVE: skal involveres i udvikling af forpligtelserne, implementeringen og monitoreringen – særlig opfordring til, at stats- og FN-aktører fra det globale Syd og Nord indgiver forpligtelser indenfor udviklingssamarbejde!
- ADDED VALUE: Fx innovative promoveringer af Handicapkonventionen eller opskalering af succesfulde tiltag. Det skal være nye forpligtelser, og ikke det man i forvejen gør.
- MEASURABLE and QUANTIFIABLE: Så de kan monitoreres og rapporteres på
- ADDRESSING GAPS: Skal adressere konkrete huller i implementeringen af Handicapkonventionen på lokalt, national eller regionalt niveau. (kunne være fra CRPD concluding observations).

Forpligtelsesmekanismen lanceres i New York under COSP i juni i år, hvor der er mulighed for at engagere stater og andre i dagsorden.

- Europa: European Disability Forum (EDF) er vært for regionalt topmøde om inkluderende udviklingssamarbejde i Berlin den 6. december 2024,
- Afrika: African Disability Forum planlægger et regionalt topmøde i Nairobi,
- MENA: Jordan afholder et regionalt topmøde i november 2024,
- Latinamerika: Riadis er i gang med at planlægge et regionalt topmøde,
- Asien og Stillehavsområdet er et svagt punkt...
